Westinghouse Electric Company (Westinghouse) submitted Topical Report (TR) WCAP-16747-P/NP, Appendices C and D, Revision 2, "POLCA-T: System Analysis Code with Three-Dimensional Core Model, Appendices C and D" (Agencywide Documents Access and Management System (ADAMS) Package Accession No. ML24267A194) for U.S. Nuclear Regulatory Commission (NRC) staff review and approval.
