 Ascension Michigan is the holding company for all of Ascension Health's southeast Michigan subsidiaries that are subject to this transaction. Through a membership substitution, Henry Ford Health System will become the sole member of Ascension Michigan. Upon closing of the Transaction, Henry Ford Health System will assume primary operational control of the Ascension Michigan subsidiaries. Following the closing, the Ascension Michigan subsidiaries (i.e., license holder hospitals) will continue to operate in the ordinary course of business and their addresses, federal employer identification numbers, and Medicare and Medicaid provider numbers will remain the same. No assignment of licenses/permits/certificates currently held by the Ascension Michigan subsidiaries will occur.

- 2. There are no changes in personnel or duties that relate to the licensed program.
- 3. There are no changes in the location, facilities, equipment, radiation safety program, use, possession, waste management, or other procedures.
- 4. The licensee's facilities, equipment, and radiation safety program, which includes calibrations, leak tests, area surveys, wipe tests, annual worker instruction, quality control and related records are up to date with no violations identified on the last NRC

- inspection on February 23, 2022. There is no known contamination therefore no decontamination of the facility will be performed prior to the transfer.
- 5. All records concerning the safe and effective decommissioning of the facility will be transferred to Henry Ford Health System d/b/a Henry Ford Medical Group Genesys. Henry Ford Health System d/b/a Henry Ford Medical Group Genesys, pursuant to 10 CFR §30.35(g), understands that they will be responsible to transfer records to the appropriate NRC region III office prior to future termination of the NRC license. All NRC records from Ascension Genesys Ambulatory Imaging will remain onsite and be transferred to Henry Ford Health System d/b/a Henry Ford Medical Group Genesys. Area surveys are performed daily, and area wipe tests are performed weekly. These documents will be transferred to Henry Ford Health System d/b/a Henry Ford Medical Group Genesys as documentation that the facility will be accepted "as is" on the date of transfer.
- 6. Ascension Genesys Ambulatory Imaging and Henry Ford Health System d/b/a Henry Ford Medical Group Genesys agree to transferring control of the licensed material and activity, and the conditions of transfer. There are no open inspection items at this time. Henry Ford Health System d/b/a Henry Ford Medical Group Genesys will abide by all constraints, conditions, requirements, representations, and commitments of Ascension Genesys Ambulatory Imaging.
