This letter documents the U.S. Nuclear Regulatory Commission (NRC) staff's plan to perform an inspection of Element Materials Technology's Appendix B, "Quality Assurance Program Criteria for Nuclear Power Plants and Reprocessing Plants," to Title 10 of the *Code of Federal Regulations* (10 CFR) Part 50, "Domestic Licensing of Production and Utilization Facilities," and 10 CFR Part 21, "Reporting of Defects and Noncompliance," programs, as they pertain to safety-related testing activities conducted at your facility for NRC regulated facilities. As discussed via Microsoft Teams meeting on Tuesday, March 25, 2025, the NRC inspection team plans to arrive at your facility on Monday, May 5, 2025, and will conduct an inspection through Friday, May 9, 2025. After the inspection, a report will be issued and transmitted to you via letter.
