**Subject:** RSCC Wire & Cable - Part 21 Ongoing Evaluation

I am writing on behalf of RSCC Wire & Cable to provide a status for our ongoing evaluation of wire and cable product related to our Part 21 initiated in July 2024 and further revised in September/October 2024.

The person who had previously been communicating with the NRC has since left the company,

so I wanted to reach out to provide an update on our review. I previously reached out directly to Paul LaFlamme and have been advised to direct this information via email.

As we communicated to the NRC in our last update to the NRC in mid-Fall 2024, during our further evaluation in September and October 2024, and as supported by a third-party audit, RSCC decided to expand the scope and breadth of its review to ensure it had identified all applicable product and corrected any process issues to the full extent.

As a result, RSCC is reviewing shipments from the past 18 months to ensure it has accounted for all non-conforming products. We identified cable(s) that could be affected and have advised customers of the issue and requested that samples be returned to our facility for further verification testing, which is a process that remains ongoing. This testing will confirm the cable's safety related function. Once the testing is complete, we will notify the NRC with an updated and final Part 21 report.

Note, our previous updates to the NRC that were not otherwise set forth in formal letters to the NRC have been via telephone. We are happy to use that route if you prefer.
