INFORMATION CONCERNING APPLICATION FOR LICENSE RENEWAL

Dear Ms. DeRafelo:

This letter refers to your application dated October 1, 2024. In reviewing your application, we found that additional information is required.

Title 10 of the *Code of Federal Regulations* (10 CFR) Section 40.52 requires the applicant submits sufficient information regarding the product pertinent to evaluation of the potential radiation exposure, please submit the following information:

- 1. Confirm that the mailing address in Section 2 of the license will now be "909 Rose Avenue, 8th Floor, North Bethesda, Maryland 20852".
- 2. Submit the proposed method of labeling or marking each unit, and/or its container with the identification of the distributor of the product and the thorium in the product.
- 3. The previous amendment lists an additional distribution location in Utah; however, your renewal application did not request the Utah location. Confirm you want to remove the Utah distribution location from the license.
- 4. Submit your annual transfer reports for Calendar Year 2024, 2023, 2022, and 2021.

We will continue our review upon receipt of this information. If we do not receive a reply from you within 30 calendar days from the date of this letter, we will assume that you do not wish to pursue your application.

In accordance with 10 CFR 2.390 of U.S. Nuclear Regulatory Commission's (NRC's) "Agency Rules of Practice and Procedure," a copy of this letter and its enclosure will be available electronically for public inspection in the NRC's Public Document Room or from the Publicly Available Records component of NRC's Agencywide Documents Access and Management System (ADAMS).
