On April 3, 2025, the U.S. Nuclear Regulatory Commission (NRC) completed an inspection at Trojan Independent Spent Fuel Storage Installation and discussed the results of this inspection with Sherri Onks, Director, Enterprise Security, and other members of your staff. The results of this inspection are documented in the enclosed report.

One Severity Level IV violation is documented in this report. We are treating this violation as a non-cited violation (NCV) consistent with Section 2.3.2 of the Enforcement Policy.
