Dear Ms. Speer Smith:

This letter concerns the subject request to amend U.S. Nuclear Regulatory Commission (NRC) License No. 21-01190-05. You had requested to add Hassan Jasser, Ph.D., as an Authorized Medical Physicist, and to remove David G. Fry, M.D., Daniel H. Macek, M.D. and Zenon Zarewych, M.D., as Authorized Users.

Based on the review, our office determined that additional information was needed from you to continue review of your amendment request. Accordingly, I prepared and sent you a written request for additional information via letter dated February 26, 2025, and emails dated March 19, 2025, and March 20, 2025. In your response letter dated March 23, 2025, you withdrew the request to remove the Authorized Users and provided additional information related to your request to add Hassan Jassar, Ph.D., as an Authorized Medical Physicist.

Upon review of the additional information provided in your letter dated March 23, 2025, I determined that the information provided did not include the information specified in my letter dated February 26, 2025, and emails dated March 19, 2025, and March 20, 2025. Specifically, your response did not include evidence that the requested individual has attained a master's or doctor's degree in physics, medical physics, other physical science, engineering, or applied mathematics from an accredited college or university, as required by [Title 10 of the Code of Federal Regulations \(10 CFR\) §35.51\(b\)](#). Therefore, the referenced request has been administratively closed. You may resubmit the request referring to Control No. 645057 for the documentation you have already submitted.

To ensure compliance with [10 CFR §35.14\(b\)](#), please provide notification no later than 30 days after an Authorized User permanently discontinues performance of duties under the license, as applicable.
