Dear Gerardo Marquez-Veglio:

This refers to your license amendment request dated March 13, 2025. Please find enclosed Amendment No. 4 authorizing a revision of the facility diagram and associated shielding calculations. Additionally, your license has been revised to correct the following errors:

- License Condition 12 was lacking the appropriate header; this has been corrected to include the header "Licensed material shall only be used by, or under the supervision of:".
- License Condition 14.A was corrected to include a closing bracket for the ADAMS accession number.
- Various minor errors in spacing were corrected throughout the document.

Please note that License Conditions 14.A and 14.B, though originally from a separate licensee, were retained as they include commitments or program descriptions that you previously committed to retaining as part of your licensing basis; they remain valid even following the revision to your facility diagram and shielding calculations.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy.
