Hello,

This email is a follow-up to the email below notifying you that a visit to the Dewey-Burdock uranium recovery site, in Custer and Fall River counties, South Dakota, has been scheduled and confirmed on Wednesday June 11, 2025, and that Powertech (the licensee) will be offering travel reimbursement to participating Tribal representatives. This email provides the details of Powertech's proposed travel reimbursement.

- Each tribe will have no more than two members of their party, except that each tribe may also invite up to two tribal elders to participate.
- The tour will be for one day on June 11, 2025.
- Tribal members participating in the site visit will be reimbursed for travel from their Tribal headquarters to the hotel (on June 10th) and from the hotel back to their Tribal headquarters on (June 12th).
- Mileage for one vehicle per Tribe will be reimbursed at the 2025 GSA rate of \$0.70/mile.
- Meals and incidental (per diem) expenses will be reimbursed at the 2025 GSA rate of \$74 per day for Fall River and Custer counties, SD. Meals and incidentals for the first and last day of travel will be reimbursed at \$55/day/per person for travel days on June 10th and June 12th, and at \$74/day/per person for tour date (June 11th).
- Hotel stay will be direct-billed to Powertech (up to two nights). Hotel location and number of rooms reserved have not yet been finalized.
- Reimbursement for travel mileage (one card per Tribe) and per diem (a card for each tribal participant) will be provided in the form of pre-loaded gift cards.

As described below, the purpose of the site visit to provide an overview of the site, overview of the area of potential effects, and overview of the areas where cultural resources have been identified. Accordingly, the plan is to:

- Meet at a central location between 7:30am and 8am MT and depart to the site.
- We will visit the area where the central processing facility will be located in the Burdock area and provide a general overview of where disturbances are anticipated.
- We will then have lunch to be provided by Powertech.
- We will visit the area where the satellite processing facility will be located in the Dewey area and provide a general overview of where disturbances are anticipated.
