Dear Frank Plastini:

This refers to your license amendment request dated March 4, 2025. Please find enclosed Amendment No. 41 which adds Leah R. Hicks, R.Ph. as an authorized nuclear pharmacist and removes Ya Min Ko, Pharm.D. and Amanda Wilfong, Pharm.D. As previously mentioned in email dated May 16, 2025, we are unable to add David C. Alderson, Pharm.D. and Garth Kistner, R.Ph. as Associate Radiation Safety Officers (ARSOs) because the NRC only recognizes ARSOs for medical uses under 10 CFR Part 35.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
