This refers to your license amendment requests dated March 17, 2025, and March 20, 2025. Please find enclosed Amendment No. 33 authorizing the release of rooms S120, S150E, S301, S396 of the School of Science building, and room 308 of the Biotech building. Additionally, the expiration date of the license was extended five years.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14)(v).
