Good morning. I have reviewed the request dated May 27, 2025, signed by Margaret Dimond, Ph.D., President, to amend U.S. Nuclear Regulatory Commission (NRC) Materials License No. 21-01430-01 to appoint Joshua Eller, CNMT, as Radiation Safety Officer (RSO), and to designate you as an Associate RSO. Upon review, I identified the following areas in which additional information or clarification is needed:

1. Please confirm that Mr. Ellers has applicable training and familiarity with the radiation safety, regulatory issues and emergency procedures for licensed material authorized in Subitems E and I of the Items 6, 7, 8 and 9, of your license, which includes any byproduct material permitted by 10 CFR §31.11 for use in in-vitro studies and fluorine-18 for use as calibration and reference standards.
2. In addition, please provide complete contact information for Mr. Eller.
3. Your request did not address the retention of Aaron Anzell as an Associate RSO. Lacking a specific request to remove Mr. Anzell as an Associate RSO, I will include both you and Mr. Anzell as Associate RSOs in the amended license. As this item is only advisory in nature, no specific response or action is needed to address it.

Please provide a written and signed response to this request within 15 calendar days, including a reference to U.S. NRC Materials License No. 21-01430-01 and Control No. 647193.
