## Commissioners,

We are a group of former NRC employees writing to you regarding the unprecedented decision by the President to fire Commissioner Hanson. This action endangers the independence of the NRC as it raises the specter of political considerations carrying greater weight than public health and safety. It must be remembered that the regulatory function of the Atomic Energy Commission was specifically transferred to the NRC in order to create an independent agency free from promoting nuclear energy that conflicted the AEC. The need for independence from politics is further emphasized by the recent Executive Orders that focus on speeding up licensing and the regulatory process.

Nobel laureate Richard Feynman wrote that "For a successful technology, reality must take precedence over public relations, for nature cannot be fooled." We urge you to consider these words and use them as a guide for your actions in coming days to ensure NRC does not become a tool of political whims and desires to the detriment of the agency's mission to ensure safe use of nuclear technology.

NRC's Principles of Good Regulation<sup>1</sup> state that:

Nothing but the highest possible standards of ethical performance and professionalism should influence regulation. However, independence does not imply isolation. All available facts and opinions must be sought openly from licensees and other interested members of the public. The many and possibly conflicting public interests involved must be considered. Final decisions must be based on objective, unbiased assessments of all information, and must be documented with reasons explicitly stated.

The agency's organizational values<sup>2</sup> call for integrity, that NRC is "trustworthy, reliable, ethical, unbiased." These standards are incompatible with capricious politics. NRC's independence has set the standard for other nations to follow, so the world is literally watching these developments. The nuclear industry's credibility relies on an objective regulator. Accidents like those at Three Mile Island, Chernobyl and Fukushima have demonstrated how events in one country can affect the world-wide nuclear industry. Succumbing to politics and surrendering NRC's independence can only reduce the effectiveness of nuclear regulation in the United States as well as around the world, increasing the likelihood of a costly accident.

Your predecessor Edward McGaffigan spoke to young staff members graduating from the Nuclear Safety Professional Development Program in 2006. His remarks<sup>3</sup> included these words:

My advice to you at the outset of your career is to bear in mind the word "honor" throughout your service. If you conduct yourself with honor, with integrity, and with diligence, you will have a great career. "Honor" often involves telling people, perhaps colleagues, perhaps supervisors, what they do not want to hear. I have throughout my career let the facts determine my position on issues. That can upset ideologs and theorists of all persuasions who do not let facts get in the way of their ideologies or their theories. And it may make you enemies. But stories I could tell you from my own career would persuade you that you can afford such enemies, but you can not afford to compromise your honor, your personal compass.

We ask that Commissioner McGaffigan's words guide you, that you set an example of integrity and honor as you lead the agency in these difficult times, following your oaths to uphold the Constitution.

This letter represents the thoughts of the individuals listed below and are based on hundreds of years of regulatory experience. We thank you for your time and consideration.
