This refers to your license amendment request dated April 7, 2025. Please find enclosed Amendment No. 1 authorizing the removal of an authorized user. The devices requested in the initial request were not added to the license based on the pending issuance of the sealed sources and devices registration and Colt's agreement to withdraw that request in an email dated June 5, 2025.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
