Fermi America plans to implement a phased approach for the submittal of the application and will provide the remaining information to the U.S. Nuclear Regulatory Commission as soon as it is ready. Summary of DPO-2024-002 RE: Code Case N-752 at Oconee

On April 28, 2025, the U.S. Nuclear Regulatory Commission's (NRC's) Office of Nuclear Reactor Regulation (NRR) issued a director's decision on a Differing Professional Opinion (DPO) submitted on May 7, 2024. The DPO raised concerns regarding the impact of the application of American Society of Mechanical Engineers (ASME) Code Case N-752 on safety classifications and treatment of components at Oconee Nuclear Station, Units 1, 2 and 3 (ONS).

The director's decision agreed with some of the DPO concerns and some of the recommendations from the DPO review panel. To carry out those recommendations, the Director of NRR assigned the appropriate NRR staff to (1) develop a plan for timely generic endorsement of Code Case N-752 that makes maximum use of the experience gained in prior approvals, and (2) provide clarity to inspection staff to ensure we are taking an appropriate risk-informed and performance-based approach to oversight of licensees' implementation of this new program through limited adjustments to relevant inspection procedures, as appropriate, with a minimal level of NRC resources.
