SUBJECT: ADVANCED ISOTOPES OF MONTANA – ACKNOWLEDGEMENT OF REPLY

TO NRC INSPECTION REPORT 030-39297/2024-001; AND NOTICE OF

VIOLATION

Dear Dr. Hart:

On May 20, 2025, the U.S. Nuclear Regulatory Commission (NRC) cited Advanced Isotopes of Montana, for two violations of NRC requirements involving the failure to: (1) have appropriate policies and procedures to address your license commitments regarding the use of germanium-68/gallium-68 (Ge-68/Ga-68) generators to prepare Ga-68 radiopharmaceuticals; and (2) ensure that hazmat employees were tested by an appropriate means on the training subjects covered in the U.S. Department of Transportation regulations. NRC Inspection Report 030-39297/2024-001 with enclosed Notice of Violation (Notice) required you to reply in writing in 30 days (NRC Agencywide Documents Access and Management System [ADAMS] Accession No. ML25139A082). In a letter dated June 16, 2025, you provided your reply to the Notice (ADAMS Accession No. ML25175A081).

After reviewing the information provided in your reply to the Notice, we have concluded that your completed and proposed corrective actions appear to adequately address the regulatory non-compliances described in the Notice. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be made available electronically for public inspection in the NRC Public Document Room or from the NRC's ADAMS, accessible from the NRC Web site at http://www.nrc.gov/reading-rm/adams.html.
