Dear James Maramba:

On May 21, 2025, the U.S. Nuclear Regulatory Commission (NRC) cited Aegeus Inspection Solutions, Inc. in NRC Inspection Report 030-38291/2025-001 and Notice of Violation (Notice). The violation involved the failure to meet certain security requirements in 10 CFR Part 37 and required a reply in writing within 30 days. Because the Notice and your response contain Security-Related Information, they are not publicly available in the NRC's Agencywide Documents Access and Management System (ADAMS), the report's transmittal letter can be found at ML25141A017.

After reviewing the information provided in your reply to the Notice, we have concluded that your completed and proposed actions appear to adequately address the regulatory noncompliance described in the Notice. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.
