SUBJECT: Request for Additional Information

Dear Sheila Swenor,

As communicated in our phone conversation on April 15, 2025, Acquisition Bell Hospital, LLC is requesting Erich Smith, MD be named as an authorized user on NRC Materials License No. 21-02037-01 for uses authorized under 35.100, 35.200, and 35.300. We have reviewed your license amendment request dated April 2, 2025. Before we can take further action in processing this request, we will need the following information:

1. 10 CFR 35.390(c)(1) requires that, in part, an authorized user must have "700 hours of training and experience, including a minimum of 80 hours of classroom and laboratory training..." Additional details to the extent of the requirements for the supervised work experience are described in paragraphs (a) through (g) of the referenced section. The documented work experience was insufficient to process this request and we are requesting the following information:
 - a. Provide additional documentation outlining the supervised work experience that Erich Smith, MD has completed which both demonstrates compliance with 10 CFR 35.390(c)(1) and is consistent with the time frame in which the training was completed. If additional dates of supervised work experience were omitted from the original submission, include the full range of dates in which the training was completed.
- OR
- b. Provide additional evidence to support an alternative pathway for naming Erich Smith, MD as an authorized user under 10 CFR 35.300.

2. 10 CFR 35.390(b)(2)(i) states the preceptor attestation must be obtained from "A preceptor authorized user who meets the requirements in § 35.57, § 35.390, or equivalent Agreement State requirements and has experience in administering dosages in the same dosage category or categories as the individual requesting authorized user status;" Please provide the following information:
 - a. Benjamin L. Viglianti MD, has been listed as the supervising preceptor. Please provide a copy of the referenced license/permit No. 92-094 which demonstrates Dr. Viglianti is an authorized user and meets the requirements of 10 CFR 35.390.

In accordance with Title 10 of the *Code of Federal Regulations* (10 CFR) 2.390 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be made available electronically for public inspection in the NRC Public Document Room or from the NRC's Agencywide Documents Access and Management System (ADAMS), accessible from the NRC Web site at <https://www.nrc.gov/reading-rm/adams.html>.

To continue review of your application, we request that you submit your response to this letter within 14 calendar days from the date of this letter (May 7, 2025). In your response, please refer to the license, docket, and control number specified below. We will assume that you do not wish to further pursue this licensing action if we do not receive a reply within the specified timeframe noted above.
