Dear Steven Corley:

This letter refers to a limited-scope routine inspection conducted on June 16, 2025, by an inspector from the U.S. Nuclear Regulatory Commission (NRC) at your permanent radiographic installation in New Castle, Delaware. The purpose of the inspection was to review activities performed under your NRC license to obtain reasonable assurance that these activities were being performed safely and in accordance with NRC requirements. Ryan Craffey of my staff conducted a final exit meeting by telephone with you on July 2, 2025, to discuss the inspection findings. This letter presents the results of the inspection.

This inspection examined activities conducted under your license as they relate to public health and safety, to confirm compliance with the NRC's rules and regulations, and with the conditions of your NRC license. Within these areas, the inspection consisted of selected examinations of facilities, equipment, procedures and records, observations of activities, and interviews with personnel.

Based on the results of this inspection, the NRC determined that one Severity Level IV violation of NRC requirements occurred. The violation was of a security-related nature and is described in the non-public Security Addendum to this letter (Enclosure 1).

The violation was evaluated in accordance with the NRC Enforcement Policy, available at <http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html>. The NRC determined that you identified the violation, corrected it prior to the conclusion of this inspection, and the violation was neither repetitive as a result of inadequate corrective action nor willful. Therefore, as a credit to your program in identifying and promptly resolving such matters, the NRC will consider this a Non-Cited Violation (NCV), consistent with Section 2.3.2 of the Enforcement Policy, and will not issue a Notice of Violation on the matter.
