CARRIE M. SAFFORD: Good afternoon, yes. We have two items today for affirmation. Today's first item is SECY-24-0103 – Pacific Gas and Electric Co. (Diablo Canyon Nuclear Power Plant, Units 1 and 2); Petition to Intervene and Request for Hearing in License Renewal Proceeding.

The Commission is being asked to act on a Memorandum and Order responding to a petition for leave to intervene and request for a hearing filed by San Luis Obispo Mothers for Peace, Friends of the Earth, and Environmental Working Group (Petitioners), which relates to the license renewal application of Diablo Canyon Nuclear Power Plant, Units 1 and 2.

The Commission has voted to approve a Memorandum and Order affirming the Board's denial of Contentions 1, 2, and 3.

In that decision, the Board denied Ms. Henderson's hearing request related to Powertech (USA) Inc.'s application to renew its in situ uranium recovery facility license.

The Commission has voted to approve a Memorandum and Order that affirms the Board's decision.
