Transmittal of information for a Foreign Ownership, Control, or Influence (FOCI) and Non-Possessing Facility Security Clearance Determination

Oklo Data Processing LLC (Oklo), a wholly-owned subsidiary of Oklo Inc., hereby submits to the U.S. Nuclear Regulatory Commission (NRC) information for a Foreign Ownership, Control, or Influence (FOCI) and Non-Possessing Facility Security Clearance Determination.

Oklo Inc. is in the process of developing a license application for a nuclear fuel recycling facility. Continued development will require detailed awareness of the Design Basis Threat for Theft and Diversion, a classified topic. In support of Oklo Inc.'s continued progress, Oklo is submitting its packet requesting a determination for a non-possessing facility security clearance.

Enclosures 1 and 2 contain information needed to request a FOCI determination and initiate the process of requesting background checks for personnel security clearances.

Oklo requests that Enclosures 1 and 2 be withheld in their entirety from public disclosure pursuant to Title 10 of the *Code of Federal Regulations*, Section 2.390, due to including security-related information as discussed in Enclosure 3.

Oklo respectfully requests NRC review and determination of the enclosed FOCI information in tandem with the company and personal information submitted through the eFOCI platform at the NRC's earliest convenience.
