

Pursuant to 10 CFR 2.101(a-1), Commonwealth Edison Company hereby tenders an application for construction permits for Carroll County Station Units 1 and 2 and also requests that the Nuclear Regulatory Commission (NRC) conduct an early review and hearing ar render an early partial decision on issues of site suitability.

Also pursuant to 10 CFR 2.101(a-1)(1), included herein as Attachment 1, is the information required by 10 CFR 50.33(a-e) and by 10 CFR 50.37.

The necessary site information and design assumptions are contained in the enclosed two self-sufficient and separate reports titled: "Carroll County Station - Site Suitability - Site Safety Report" and "Carroll County Station - Site Suitability - Environmental Report."
