Title: Public Meeting to Discuss the Modified Rulemaking Process for the American Society of Mechanical Engineers (ASME) Code Cases and Code Editions Rules

Category: This is an Information Meeting with a Question and Answer Session. The purpose of this meeting is for the NRC staff to meet directly with individuals to discuss regulatory and technical issues. Attendees will have an opportunity to ask questions of the NRC staff or make comments about the issues discussed throughout the meeting; however, the NRC is not actively soliciting comments towards regulatory decisions at this meeting.

Purpose: To engage with the public and provide an overview of the recently modified process for ASME rulemakings. This includes approving unconditioned and noncontroversial code cases using the direct final rulemaking process, and combining the approval of conditioned and/or potentially controversial ASME code cases and incorporation by reference of new code editions into one separate rulemaking.
