Dear Mr. Diaz:

This letter refers to your application dated May 30, 2025, requesting to a U.S. Nuclear Regulatory Commission (NRC) exempt distribution license. We do not have sufficient information to complete a review of your application. To continue our review, we need additional information as requested below.

- 1. Please confirm the address that will be listed in Section 2 of the license. Your NRC possession license number 42-26928-01 has the main address in Section 2: 6510 West San Houston Parkway North Houston, Texas 77041.
- 2. Please confirm the address(s) where the material will be initially distributed from to temporary jobsites. These locations should be listed on a possession license if trucks are dispatched from district offices. Provide a copy of the possession license(s), as applicable.
- 3. Please provide the estimated time interval between introduction and transfer of the product or material.
- 4. Your application states that the pumps will ensure that no more than the specified concentrations are introduced into fracking fluid. On page 3 of your application, you state that adjustments may be needed depending on the information provided by the service company. Please provide control methods for reasonable assurance that the pumps are functioning as intended and to account for adjustments in the field.
- 5. Proprietary information submitted to the NRC may be withheld from public disclosure. To do this, you must follow the procedures in Title 10 of the *Code of Federal Regulations* (10 CFR) Paragraph 2.390(b) including requesting withholding at the time the information is submitted and complying with the document marking and affidavit requirements set forth in 10 CFR 2.390(b)(1).
