Dear Natalia Santos:

This refers to your license amendment request dated April 25, 2025. Please find enclosed Amendment No. 5 authorizing your license to continue operating in its active status and granting a request to extend the start of decommissioning pursuant to 10 CFR 30.36(f). In a letter dated July 29, 2025, you committed to maintaining the necessary training for all the relevant staff and to notify the NRC in writing within 7 days once it is determined that patient treatment involving radioactive materials will be scheduled.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with the NRC will result in enforcement action(s) against you. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy.
