## 1) Licensee Name Change (item #1)

- The request for more information or to define the name change classification. This is a name change request only! Change in name from Irisndt, Inc. to Apave America.
- Vehicles assigned to NRC locations will have the logo's changed to identify Apave IRISNDT.
- Site RSO's and authorized persons with source retrieval certifications shall be used in emergency situations to perform source retrievals and maintain the security of our Radiation protection programs.
- 2) We are not decommissioning any sites or facilities. (item #4 & 6)
  - To Qualify a response affirming that the radiation protection program, facilities and equipment remain in use in accordance with the existing license
  - The radiation protection program, facilities and equipment in use are currently the same as the IRISNDT system that was in place. *Updated procedures included in email for reference with the new Apave identification*.
  - All associated records from IRISNDT are current and will be maintained by Apave America.
  - Leak test records from IRISNDT are current and will be maintained by Apave America
  - See Statement below for confirmation of decommissioning statement!
- 3) IRISNT representative (currently now Apave America) signature confirming transfer of control of application (see Below) (item #7)
- 4) Statement identifying Apave will abide by all constraints, conditions, requirements, representations and commitments of the transferor (IRISNDT, Inc.) (Item #8) See Below
