This letter concerns the subject request to amend your U.S. Nuclear Regulatory Commission (NRC) License No. 06-08349-04. You requested to add a new high dose-rate remote afterloader model to your NRC license in anticipation of an upgrade. Your amendment request is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML25226A102.

Based on the email dated August 14, 2025, by Gerald J. Randall, M.S., your Radiation Safety Officer, and as confirmed Mr. Randall via telephone on Tuesday, August 19, 2025, the NRC was informed that you no longer wished to pursue the requested action and are withdrawing the amendment request. Therefore, we have administratively closed your license amendment request. Note that following October 1, 2025, if you wish to continue with these changes to your facility, you will have to submit an amendment request to the State of Connecticut Department of Energy and Environmental Protection.
