This refers to your license amendment request dated August 19, 2025. Please find enclosed Amendment No. 2 authorizing the use of the additional gun site model Family 4 for receipt, possession, handling, testing, packaging and distribution.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
