Diana,

After our call we dug in a little more on the conservation measures and #7 really stood out to me for 2 reasons. The first, the text added in red says “shafts” plural when the entire paragraph is only discussing the Triangle Mine ventilation shaft. Second, we don’t understand how USFWS went from just putting a buffer around the shaft to having to “reinitiate ESA Section 7 consultation.” Powertech would prefer to add in additional mitigation rather than reinitiate Section 7.

Would it be possible to set up another meeting early next week to discuss with you and Mitchell?
