By letter dated March 8, 2024 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML24072A267), Westinghouse Electric Company (Westinghouse) submitted Topical Report (TR) WCAP-18869-P/NP, Revision 0, "High Performance Cladding for Use in Boiling Water Reactor Fuel" (Proprietary/Non-proprietary), for the U.S. Nuclear Regulatory Commission (NRC) review and approval. Based on its review of the information submitted in the TR, the NRC staff finds the TR acceptable for referencing subject to the limitations specified in the TR, and in the NRC safety evaluation (SE).

Pursuant to Section 2.390 of Title 10 of the *Code of Federal Regulations* (10 CFR), we have determined that the draft SE may contain proprietary information.
