
On behalf of Little Company of Mary Hospital of Indiana Inc d/b/a Memorial Hospital and Health Care Center License No. 13-09274-03 (the "Licensed Provider"), please accept this correspondence as formal notification of a change in legal business name and assumed business name for the Licensed Provider. **Effective August 1, 2025, the Licensed Provider will become Deaconess Memorial Medical Center, as evidenced by the enclosed approval from the Indiana Secretary of State.**

Deaconess Memorial Medical Center's name change is not due to a change in ownership. Rather, this name change reflects the Licensed Provider's continued integration with Deaconess Health System's commitment to expanding services, providing more innovative treatments and continuing to provide better access to specialized care. No changes to the Licensed Provider's tax identification number, ownership, legal name, officers, or location were made in connection with this change in legal business name. Deaconess Memorial Medical Center notified the Internal Revenue Service of its legal business name change. Upon receipt of the revised 147-C correspondence, Deaconess will notify its Medicare Administrative Contractor and other payors and file any additional documentation to update its enrollment record.


