SUBJECT: SUMMARY OF SEPTEMBER 8, 2025, CLOSED MEETING WITH  
CONSTELLATION ENERGY GENERATION, LLC, REGARDING A PLANNED  
LICENSE AMENDMENT REQUEST TO REVISE THE SITE SECURITY PLAN  
TO SUPPORT RESUMPTION OF POWER OPERATIONS  
(EPID L-2025-LRM-0018)

On September 8, 2025, a closed meeting was held between the U.S. Nuclear Regulatory Commission (NRC) and representatives of Constellation Energy Generation, LLC (Constellation, the licensee) at NRC Headquarters in Rockville, MD. The purpose of the meeting was to discuss a proposed license amendment request to revise the site security plan for the Christopher M. Crane Clean Energy Center (CCEC) to support potential restart of the unit. The meeting notice and agenda, dated May 19, 2025, are available in the Agencywide Documents Access and Management System (ADAMS) Accession No. ML25227A131. A list of attendees is provided as an enclosure to this summary.

The meeting began with introductions and opening remarks from the NRC staff, followed by introductions of Constellation staff. The licensee then moved into their presentation for the meeting, which began with the purpose and goals for the meeting, and background information on past revisions to the security plan. The licensee then discussed changes to the plan since the last approved revision when the unit was operating and proposed changes to the plan regarding weapons systems, infrastructure, and additional changes Constellation would consider under Title 10 of the *Code of Federal Regulations* (10 CFR) Section 50.54, "Conditions of Licenses," paragraph (p), following implementation of the proposed security plan, if approved. Constellation concluded the presentation with their planned submittal schedule and discussion with the NRC staff.

The NRC staff asked the licensee several questions throughout the presentation regarding proposed changes to the security plan, operation of a proposed weapons system, mitigations for insider threats, the cyber security plan, and the timeline for implementing changes to the proposed security plan under 10 CFR 50.54(p). The licensee provided responses during the meeting. Additionally, the NRC staff noted several changes to the digital assets in the planned restart and questioned the state of the cybersecurity program. The licensee stated that the cybersecurity program is managed by a department that was not present at the meeting. The licensee agreed to a future discussion with the NRC staff on updates/changes and reestablishment of their cybersecurity program.

In addition to questions directly related to the planned LAR, a senior manager at the NRC asked if Constellation would share with the NRC staff any new or updated regulations that directly resulted in the licensee needing to upgrade or replace hardware and/or software for their security plan. The licensee responded that the changes proposed were business decisions to align the site with the Constellation fleet. The same individual also asked if Constellation would share any security systems they considered as alternatives to the ones they plan to propose in the LAR, so the NRC staff can stay abreast of emerging technologies. These requests were not suggestions for information to include in the submittal.

At this meeting, the NRC staff made no regulatory decisions. No Public Meeting Feedback Forms were received.
