Subject: Request for Transfer of Control – NRC License No. 21-26253-01

Dear Ms. Gryglak,

On behalf of Radiological Physics Service, Inc. (RPS) (“Transferor”) and Versant Medical Physics and Radiation Safety, LLC (Versant) (“Transferee”), we respectfully submit this request for transfer of control of NRC License No. 21-26253-01 from RPS to Versant.

This request is submitted in accordance with NUREG-1556, Volume 15, Rev. 1, Appendix E. Both the Transferor and Transferee have reviewed the requirements and provide the following information:

1. Planned Organizational Changes

The licensed operations currently conducted under RPS will be transferred in their entirety to Versant. This transfer represents a change of ownership/control only. Versant Medical Physics’ legal address and primary contact are:

RPS will no longer conduct NRC-licensed activities following the transfer.

2. Personnel and Duties

Versant will designate Dr. Eric B. Ramsay, Ph.D. as the Radiation Safety Officer (RSO) and continue to employ authorized users currently listed on the license. Training and qualifications remain consistent with prior commitments. Any personnel updates will be submitted as required.

3. Licensed Program (Facilities, Equipment, Procedures)

No changes are planned to locations of use, facilities, equipment, radiation safety program, possession limits, waste management, or other procedures authorized under the license. The currently authorized location at 3847 Napier RD., Plymouth, MI 48170 will remain on the license as a site of use following transfer. No additional locations are

requested.

4. Status of Facilities and Program

All facilities and equipment remain in good standing. Calibrations, leak tests, surveys, wipe tests, training, and quality control records are current. No contamination is known to exist requiring decontamination prior to transfer.

5. Decommissioning Funding / Financial Assurance

The licensed activities do not require a decommissioning funding plan. No changes to financial assurance instruments are required.

6. Transfer of Records

All records related to safe and effective decommissioning (including surveys of radiation levels and contamination checks) will be transferred to Versant Medical Physics and maintained in compliance with NRC requirements.

7. Agreement of Transfer

Both the Transferor and Transferee hereby agree to the transfer of control of License No. 21-26253-01, acknowledge any open inspection items, and recognize that the Transferee accepts responsibility for potential enforcement actions arising from prior activities.

8. Commitments

Versant commits to abide by all existing license constraints, conditions, requirements, representations, and commitments previously made by RPS.

9. Financial Qualifications (Not Applicable)

This request does not involve a fuel cycle facility; therefore, submission of financial qualifications is not applicable.
