Cisco Enterprise Agreement for Hardware, DNA Licensing, and Maintenance

On September 17, 2025, contract number NNG15SD73B/31310025F0106 was awarded to DISYS Solutions, Inc. in Ashburn, VA. The purpose of this contract is to obtain a Cisco Enterprise Agreement that consists of Cisco Hardware, DNA Licensing and Maintenance from an authorized reseller. The period of performance is from October 1, 2025, through September 30, 2026, with no option periods. The total potential value of this contract can be up to \$1,266,443.58.

Adobe Software Licenses

The purpose of this contract is to renew existing Adobe software licenses and associated support services currently deployed across the NRC.
