3. Exemption from NRC regulations to dispose of sources with a half-life of greater than 120 days

We are requesting that **Good Samaritan Hospital** be given an exemption from the NRC regulations to dispose of sources with a half-life of greater than 120 days. The sources in question are attached **separately(Attachment 1)** to this request and have decayed to an inert state. Based on 10 CFR 20.2002 the director can approve the proposed disposal of materials that are not otherwise authorized in these rules for the disposal of licensed material generated in the licensee's operations:

The respective sources have decayed to a degree where the sources have negligible activity and are demonstrating surface exposure readings equivalent to background using a low level GM survey meter on its most sensitive setting. The collective survey and a single wipe test was performed on all the sources on May 14, 2025. The survey and wipe test results for the sources are: Background: 0.01 mR/hr Surface Reading: 0.01 mR/hr Wipe Test: 0 dpm

Upon approval, the sources will be completely defaced prior to standard landfill disposal.

We appreciate the opportunity of submitting this request to dispose of these sources. The Radiation Safety Officer and Administration of Good Samaritan Hospital have approved this request. If you have any questions regarding this notification, please contact me at 812-885-3628.


