Pursuant to 10 CFR § 30.34(b), Dr. Mustafa M. Hassan requests approval to transfer control of NRC License No. 21-26540-01, currently held by Premier Medical Clinics, located at 1165 S. Linden Road, Flint, MI 48532. This transfer of control accompanies Dr. Hassan's purchase of Premier Medical Clinics from Dr. E.G. Raj.

Transferee Qualifications

- Mustafa M Hassan, MD is an authorized user on Heart Rhythm Clinic of Michigan, License No. 21-32110-01. Dr. Hassan and staff are trained and qualified per 10 CFR § 35.290 for the safe use of byproduct material in diagnostic procedures.
- Resources are maintained for safe operation and decommissioning per 10 CFR § 30.35.
- Existing radiation safety program, overseen by our medical physics service consultant and compliant with 10 CFR Part 20, will extend to the acquired facility.

Transaction Details

The purchase transfers ownership of Premier Medical Clinics licensed byproduct materials and responsibilities for diagnostic use at 1165 S. Linden Road, Flint, MI 48532.

No changes to radiation safety or security plans are proposed.

The location, facilities, equipment, and procedures will remain intact.
