The Commission is being asked to act on a final rule to rescind a discrete number of regulations in Title 10 of the Code of Federal Regulations Parts 2 and 14 because they are either inconsistent with statutory requirements or duplicative of statutory requirements and other binding regulations. These rules govern the conduct of NRC proceedings or internal agency practices, and this action will not impinge on the substantive rights of any party.

The Commission has voted to approve the publication and implementation of this final rule. The Commission has also certified, under the Regulatory Flexibility Act, that this rule will not have significant economic impact on a substantial number of small entities.
