SUBJECT: SUMMARY OF SEPTEMBER 08, 2025, PARTIALLY CLOSED
PRE-APPLICATION LICENSE AMENDMENT REQUEST AND
INTEGRATED SAFETY ANALYSIS SUMMARY SUBMITTAL
PUBLIC MEETING WITH WESTINGHOUSE COLUMBIA FUEL
FABRICATION FACILITY

On September 08, 2025, the U.S. Nuclear Regulatory Commission (NRC) staff held a virtual partially closed public meeting with Westinghouse Columbia Fuel Fabrication Facility (Westinghouse CFFF) staff. Westinghouse CFFF staff requested this meeting to discuss the license amendment request and integrated safety analysis summary for their proposed low enriched uranium plus facility expansion at their currently licensed fuel fabrication facility in Hopkins, South Carolina. This facility expansion will be used to manufacture light water reactor fuel enriched up to 8 percent uranium-235. The first session of the meeting was open to the public while the second session was closed to the public for discussion of proprietary information.
