

U.S. Nuclear Regulatory Commission Approved a Notice of Enforcement Discretion Request for VC Summer Unit 1

On November 14, 2025, the U.S. Nuclear Regulatory Commission (NRC) staff verbally approved a Notice of Enforcement Discretion (NOED) request for VC Summer Unit 1 to not enforce TS 3.7.1.2 Action "a" to allow for repair of the Turbine Driven Emergency Feedwater Pump. The verbal approval exercised enforcement discretion for an additional 79 hours beyond the 72 hours allowed by the Technical Specifications that expired at 2:08 am on November 15, 2025. The licensee returned the pump to operable status at 5:47pm on November 16, 2025.

NRC Hosted a Public Meeting Related to the Reactor Oversight Process

On November 19, 2025, the NRC staff hosted a public meeting related to the Reactor Oversight Process (ROP), highlighting proposed revisions to the Baseline Inspection Program and the NRC's Differing Views Program as described in the ADVANCE Act Section 507 report to Congress. The meeting discussed some of the proposed revisions that will go into the notation vote SECY to the Commission, including: the new proposed engineering inspection procedure, the new proposed problem identification and resolution team inspection procedure, radiation protection inspection procedures update, an update to the emergency preparedness Significance Determination Process revision, and an overview of the revision to the NRC's Differing Views Program. Attendees included representatives from the Nuclear Energy Institute (NEI), the industry, and members of the public. The next bi-monthly public meeting on ROP-related matters is tentatively scheduled for January 29, 2026.

NRC to Publish Draft Interim Staff Guidance, DSS-ISG-2025-XX, "Treatment of Certain Loss-of-Coolant Accident Locations as Beyond-Design-Basis Accidents," for Public Comment

On November 24, 2025, the NRC intends to publish a notice in the *Federal Register* requesting public comments on draft Interim Staff Guidance (ISG), DSS-ISG-2025-XX, "Treatment of Certain Loss-of-Coolant Accident Locations as Beyond-Design-Basis Accidents." Members of the public may submit comments during the 30-day comment period on the draft ISG found under (Agencywide Documents Access and Management System (ADAMS)) Accession No. [ML25043A335](#).

NRC Signs Its Safety Evaluation for the Kemmerer Power Station Unit 1 Construction Permit Application

On November 28, 2025, the staff plans to sign its safety evaluation (SE) for the Kemmerer Power Station Unit 1 construction permit application (ADAMS Accession No. ML25329A252) and intends to issue it publicly on December 1, 2025. This application is the first use of a fully risk-informed, performance-based approach following the licensing modernization project methodology. The SE was completed 9 months ahead of the original 27-month schedule thanks to enhanced licensing practices, including a dedicated core team, extensive audits, streamlined documentation and internal review processes, and focused reviews by the Office of the Advisory Committee on Reactor Safeguards and the Office of the General Counsel.
