U.S. Nuclear Regulatory Commission (NRC) Staff Accepted a License Amendment Request (LAR) For Review to Revise the Christopher M. Crane Clean Energy Center (CCEC) Site Emergency Plan in Support of Plans to Resume Power Operations

On December 9, 2025, the U.S. Nuclear Regulatory Commission (NRC) staff accepted for review a license amendment request (LAR) by Constellation Energy Generation, LLC (CEG) to revise the site emergency plan in support of their plans to resume power operations at the Christopher M. Crane Clean Energy Center (CCEC). This LAR is the final licensing action CEG plans to submit as part of their regulatory strategy to return to the operating reactor licensing basis and enable restart of the CCEC.

The Office of Nuclear Reactor Regulation (NRR) Issued a Memo to Provide Expectations Around the NRC Staff's Involvement with Prospective Applicants Planning to Utilize a Prior DOE or DOW Authorization When Pursuing an NRC License of a Same or Similar Design

On December 11, 2025, the Director of Office of Nuclear Reactor Regulation (NRR) issued a memo to provide expectations around the NRC staff's involvement with prospective applicants planning to utilize a prior Department of Energy (DOE) or DOW authorization when pursuing an NRC license of a same or similar design. Participants in the DOE/DOW authorization programs that are considering future NRC licensing may choose to seek early engagement with the NRC to ensure they are positioned to appropriately leverage existing DOE/DOW authorizations. While the initiation of these engagements is voluntary and remains in prospective applicant's control and responsibility, the NRC staff should proactively work to facilitate these engagements as noted in this memorandum and its enclosure. The staff plans to develop further guidance for both applicants and the NRC staff as further progress is made with the DOE authorization pilot program, and the outcome and details of that process become clearer.

NRC Staff Presented to More Than 30 Industry Participants at the Mo-99 Stakeholder Meeting in Washington, D.C.

On December 11th, 2025, NRC staff presented to more than 30 industry participants at the Mo-99 Stakeholder Meeting in Washington, D.C., hosted by Argonne National Laboratory and the National Nuclear Security Administration. List of Approved Spent Fuel Storage Casks: NAC International, Inc., NAC-UMS® Universal Storage System, Certificate of Compliance No. 1015, Renewed Amendment No. 10, and Revision 1 to Renewed Amendment Nos. 5 Through 9; 10 CFR Part 72 [NRC-2025-0025; RIN 3150-AL30]
