The purpose of this email is to acknowledge receipt of the letters from Summit NDE, LLC, that were transmitted on 12/19/2025, in response to the U.S. Nuclear Regulatory Commission's (NRC) letter dated 12/18/2025, transmitting a Notice of Violation.

In the 12/19/2025, letters, you identified the corrective actions that your company has taken or plans to take to address the violations.
