PROPOSED AMENDED AGREEMENT BETWEEN THE STATE OF WYOMING AND THE U.S.  
NUCLEAR REGULATORY COMMISSION (STC-26-004)

**Purpose:** To notify you that the U.S. Nuclear Regulatory Commission (NRC) has published a *Federal Register* notice (FRN) requesting comments on the proposed amended Agreement between the State of Wyoming and the NRC.

**Background:** Governor Mark Gordon, on behalf of the State of Wyoming, has submitted a request that the NRC enter into an amended Agreement with the State pursuant to Section 274 of the Atomic Energy Act of 1954 (AEA). Under the proposed amended Agreement, the Commission would discontinue, and the State of Wyoming would assume regulatory authority over source material recovered from any mineral resources processed primarily for purposes other than its uranium or thorium content.

**Discussion:** In the FRN, the NRC staff includes the proposed amended Agreement with the State of Wyoming and summarizes its assessment of the Wyoming program for exercising regulatory authority over source material recovered from any mineral resources processed primarily for purposes other than its uranium or thorium content. This draft assessment was originally provided to the NRC Commission in Enclosure 2 to SECY-25-0096, "Proposed Amended Agreement Between the State of Wyoming and the Commission Pursuant to Section 274 of the Atomic Energy Act of 1954, as Amended" ([ML25237A058](#)).
