

Duke Energy Early Site Permit Application

On December 30, 2025, Duke Energy submitted to the U.S. Nuclear Regulatory Commission (NRC) an early site permit application for a site near the Belews Creek Steam Station in Stokes County, NC. The application is based on a plant-parameter envelope, encompassing six potential reactor technologies. Staff plans to conduct a 45-day acceptance review of the application.

Holtec International Company

On December 30, 2025, SMR, LLC, a Holtec International Company, submitted to the NRC Part 1 of an application for a construction permit for a dual-unit SMR 300 plant at the Palisades Energy Center in Covert, Michigan. This first part of the application includes a request for a Limited Work Authorization with accompanying exemptions to authorize certain construction activities prior to issuance of a full construction permit. As required by regulations, Part 2 of the application will be filed no later than 18 months after Part 1. The new units are named Pioneer Unit 1 and 2. Staff plans to conduct a 45-day acceptance review of the application.
