On August 28, 2025, the U.S. Nuclear Regulatory Commission (NRC) cited High Mountain Inspection Service, Inc. in NRC Inspection Report 030-33887/2025-001 and Notice of Violation. The report cover letter can be accessed through the NRC's Agencywide Documents Access and Management System (ADAMS) at Accession Number [ML25240B636](#). The Notice required a reply within 30 days and your response was received on September 21, 2025.

After reviewing the information provided in your reply to the Notice, we have concluded that your completed and proposed actions appear to adequately address the regulatory noncompliance described in the Notice. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.
