

A meeting of criticality safety experts is scheduled to be held January 13 and 14, 1999, at NRC Headquarters in Rockville, Maryland (Room OWFN-6B11 at 11555 Rockville Pike, across from the White Flint metro station). The purpose of the meeting is to discuss comments received on the [draft rule](http://techconf.llnl.gov/cgi-bin/downloader/dom_lic_lib/042-0004.htm) and on the staff [draft standard review plan chapter on criticality safety](http://techconf.llnl.gov/cgi-bin/downloader/dom_lic_lib/042-0013.htm), and other criticality issues as they relate to Part 70.
