3. any and all reports, correspondence, notes, plans, videos relating to "SVA Decommissioning Plan" dated April 1, 1990, as revised August 22, 1990
4. any and all reports, correspondence, notes, videos relating to the approval and release of the work done by License No. SNM-696 in particular the time period August 1995 through October 1995.

8. all copies of correspondence, notes, internal memorandums, reports, findings, conclusions, photos, opinions and documents of whatever nature that pertains in anyway to the NRC's Notice of Violation issued on February 28, 1992

9. all copies of correspondence, notes, internal memorandums, reports, findings, conclusions, photos, opinions and documents of whatever nature by or received by NCR that pertain in a any way to the shutdown period (January 1992-May 1992) or to the readiness review undertaken by General Atomics

I am aware I am entitled to make this request under the Freedom of Information Act, and if your agency's response is not satisfactory, I am prepared to make an administrative appeal. Please indicate to me the name of the official to whom such an appeal should be addressed.

I am aware that if my request is denied I am entitled to know the grounds for this denial.

I am aware that while the law allows your agency to withhold specified categories of exempted information, you are required by law to release any segregable portions that are left after the exempted material has been deleted from the data I am seeking.


