
South Texas Project Nuclear Operating Company (STPNOC) submitted the above referenced amendment requests in support of the STP steam generator replacement. Replacement for Unit 1 is scheduled to commence at the beginning of March 2000, and for Unit 2 in the fall of 2002.

The above referenced amendment requests specify an implementation period directly associated with the Unit 1 replacement outage. STPNOC and the U.S. Nuclear Regulatory Commission (NRC) staff reviewed these requests and agreed that it would be preferable to implement them in the usual manner once they are approved, as opposed to waiting until the Unit 1 steam generators are replaced.

Accordingly, STPNOC hereby requests that amendments to STP technical specifications shown in References 1 through 4, above, be approved with a thirty (30) day implementation period.
