
In accordance with the Vermont Yankee Technical Specifications (TS), please find enclosed the Core Operating Limits Report (COLR) for Vermont Yankee Cycle 20, Revision 3, dated September 1999. This report presents the cycle-specific operating limits for the operation of Cycle 20 of the Vermont Yankee Nuclear Power Station.

It should be noted that in COLR section 1.0 INTRODUCTION, that TS section 6.7.A.4 is listed as the TS section reference. Due to the implementation of Amendment 171 at the same time this report revision was being developed, this administrative section of TS relating to the COLR was re-numbered to 6.6.C. Additionally, the REVISION RECORD page of the report states that proprietary information is contained in the document. This report does not contain proprietary information. These discrepancies are purely editorial and do not affect the technical content of this report. The reference and proprietary statement will be revised with issuance of the Cycle 21 COLR.
