SUBJECT: ADEQUACY OF KAOWOOL FIRE BARRIERS

Dear Mr. Morey:

I received your letter dated September 23, 1999, regarding the adequacy of Kaowool Fire Barriers in use at the Farley Nuclear Plant. Your letter indicates that you disagree with several statements contained in our letter on this subject dated August 26, 1999, and its enclosure, the NRR response to TIA 96-023.

We appreciate your support for a joint meeting between NRC, you, and three other commercial nuclear power facilities that currently use Kaowool or FP-60 fire barriers. As indicated in our letter to you dated September 9, 1999, and reiterated during a telephone conference call between members of your staff and the NRC on October 5, 1999, the objective of this meeting will be to explore the possibility of developing a voluntary industry initiative to resolve the Kaowool and FP-60 issues. The meeting discussions will include a review of the technical and licensing basis issues associated with the use of Kaowool and FP-60 fire barriers, their applicability to each plant, and the need for compensatory measures. If, after the completion of this joint meeting, you continue to desire a meeting solely between your staff and the NRC, we will arrange for such a meeting.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be placed in the NRC Public Document Room.

The NRR lead project manager for this issue, Mr. Leonard Olshan, who can be reached at (301) 415-1419, will inform your staff of the arrangements for the joint meeting. Please contact Mr. Olshan or me if you have any additional questions in this regard.
