This modification is issued to: (1) exercise Option Year No. 1; (2) increase the contract ceiling and obligated amounts by \$67,000 from \$64,980 to \$131,980; (3) change the project officer; and (4) extend the period of performance. The contract is therefore modified as follows:

1. In accordance with paragraph C.6, OPTION FOR INCREASED QUANTITY-SEPARATELY PRICED LINE ITEM (MAR 1989), NRC hereby exercises Option Year No. 1.
2. Paragraph B.3, CONTRACT DURATION PERIODS, is deleted in its entirety and replaced with the following:

 "The period of performance for this contract shall commence on 10/31/98 and will continue through 10/31/00. The term of the contract may be extended at the option of the NRC for an additional three (3) one-year periods."
3. Paragraph C.4, 2052.215-73 PROJECT OFFICER AUTHORITY-ALTERNATE 2, is modified to designate Penelope M. Kinney as project officer.
